

Registration Rules and Regulations for the 8th World Mahjong Championship

I. General Principles

To ensure the standardized and orderly implementation of registration for the 8th World Mahjong Championship (hereinafter referred to as "the Tournament"), the detailed rules are set forth below in accordance with the Competition Regulations of the 8th World Mahjong Championship and relevant provisions of the Organizing Committee.

II. Participation Quotas

The total number of participants for the Championship is planned at approximately 212 persons, with the following specific quotas:

European players: no fewer than 56 quotas;

Chinese players (including Hong Kong, Macao, and Taiwan): no fewer than 56 quotas;

Players from other countries and regions: 100 quotas.

III. Registration Priority Rules

Outstanding players recommended by each member organization of the World Mahjong Organization shall be granted priority for registration eligibility.

Registration is open to all players complying with International Mahjong Competition Rules (MCR). Priority will be given to early applicants, and registration closes once the quota is full.

Registration fees must be fully remitted to the designated account of the Organizing Committee before an application can be accepted. Any participant who fails to complete the full payment to the designated account by the deadline shall be deemed to have voluntarily forfeited their registration eligibility.

IV. Eligibility and Registration Procedures

Eligibility: Any mahjong enthusiast who adheres to the international Mahjong Competition Rules (MCR) promulgated by the World Mahjong Organization (WMO) and complies with the regulations of the Championship may register either through the recommendation of a WMO member organization in their country/region, or directly with the Organizing Committee. Mahjong enthusiasts from regions without a member organization may apply directly to the Organizing Committee for registration.

Registration Materials: Players must provide their full name, gender, nationality/region, team name (if applicable), a copy of a valid identification document and an electronic photograph.

Registration Deadline: September 20, 2026 (subject to the Organizing Committee's receipt of complete application documents and registration fees). No applications will be accepted after the deadline.

V. Ranking Methods

Individual Ranking: Ranked by each player's total score.

Team Ranking: Ranked by the total scores of all players in each team (4 players per team), aggregated under the team name.

National Group Ranking: Ranked by the total scores of the top four players from each country/territory, aggregated by nationality.

VI. Other Matters

All participants shall handle visa, insurance and other relevant procedures on their own. The Organizing Committee may provide necessary assistance.

When remitting payment to the designated account of the Organizing Committee, participants must state the registered participant's name in the remittance remark.

The Organizing Committee reserves the right of final interpretation of these Detailed Rules. Any matters not covered shall be subject to subsequent announcements issued by the Organizing Committee.
